

# LOCAL STUDENTS SELECTED AS WASHINGTON YOUTH TOUR DELEGATES



Wouldn't it be nice to know about a sudden increase in your energy use before you get a high electric bill and early enough to reduce it? Now you can by setting up "My Alerts" on your Colquitt EMC account.

"My Alerts" is an automatic notification system that will send you a text, email, or voice mail message within 24 hours of an unusual increase in your energy use. It's like a warning light for changes in your energy use that could result in a high electric bill.

Setting up "My Alerts" is easy. Just access you Colquitt EMC account on the Colquitt EMC website or mobile app. Select the "My Alerts" tab and follow the instructions. The only information you need is your target daily cost (your monthly electric bill budget divided by 31) and how you wish to be notified if you exceed your target daily cost, (text, email, or voice recording).

To calculate the target daily energy \$ amount,

divide your target desired monthly power bill amount by 30.5 (the conversion factor). For example, if your target desired power bill is \$100, divide \$100 by 30.5 to get \$3.28.

## ENERGY EFFICIENCY TIP OF THE MONTH

Turn your suds into savings.

Lower your energy use in the laundry room by washing clothes with cold water whenever possible, as heating water accounts for most of the energy used in a laundry cycle. Wash full loads to make the most of energy savings, and use high-efficiency detergent designed for cold washes. For drying cycles, clean the lint filter before each load to improve airflow and use dryer balls to reduce drying time.




## TIPS TO AVOID ENERGY SCAMS

Don't fall for a power restoration rip off. Some scammers will contact you and offer to restore power quickly or in a preferential order if you make an immediate payment. These scams typically occur after major storms or disasters that cause widespread outages. We will never request or require payment to restore power after a natural disaster or storm. If post-storm repairs to customerowned equipment are necessary, we will advise you to work with a licensed contractor. If any charges are applicable, you will be billed through your account.

Colquitt EMC Scholarship Applications are available April 1 through June 15. Applicants must:

- Reside in the household of a Colquitt EMC Member.
- Be enrolled in a college or technical college with campus locations/degree offerings within Colquitt EMC's service area.

#### **Lemon Poppy Seed Cake**

#### **INGREDIENTS**

- 1 (18 1/4 oz) yellow cake mix (with or without pudding)
- 1 (3 oz) instant lemon pudding mix
- 1/2 cup vegetable oil
- 4 eggs
- 1 cup warm water
- ½ cup poppy seeds (to taste)

#### Glaze

- 2 lemons, juiced
- 1 ½ cups powdered sugar

#### **DIRECTIONS**

Preheat oven to 350 degrees F. Grease a bundt pan. Beat together cake ingredients with an electric mixer for about 4 minutes. Pour the batter into prepared bundt pan. Bake for 45 minutes or until toothpick tests clean. While cake is baking, mix lemon juice with powdered sugar for the glaze. It should have a thin consistency to sink into the cake. When cake is done and still hot, poke holes all over it while still in the bundt pan with long skewers and pour glaze over it. Allow cake to cool and then remove from the pan.
